## Privacy Notice

This Privacy Notice tells you how the event organiser (Society "Firefighter Combat Challenge Team Austria") processes your personal data in the context of its relationship with participants of the event 6. Austrian Firefighter Combat Challenge.

### 1. What Personal Data We Collect

We process the following types of personal data from Participants:

- **Contact information:** name, address, phone, email, gender, birth date
- **Commercial information:** bank details
- **Performance metrics:** runtime, disqualifications, penalty times, failures
- **Event management information:** event details, membership fire department, suitability for respiratory protection respectively medical examination certificate, clothing size, photos, videos

### 2. Why We Collect, Use and Store this Personal Data

We collect, use and store your personal data for the reasons set out below:

- **Where you have given consent** (where we ask for consent, you are free to withhold or revoke it). The consent form "Data Processing Notice regarding DSGVO" is at the next page
- Where necessary for Society "Firefighter Combat Challenge Team Austria" legitimate interests, as listed below, and where our interests are not overridden by your data protection rights
  - o Making Dealer contact details available to Society "Firefighter Combat Challenge Team Austria" personnel, third parties providing services to participants
  - o Planning our business and operating the event 6. Austrian Firefighter Combat Challenge
  - o Considering the performance of the Participants, as required to evaluate their performance
  - o Maintaining the security of our equipment, facilities and electronic as well as technical platforms
- Where this is necessary for Society "Firefighter Combat Challenge Team Austria" to administer and conduct the event 6. Austrian Firefighter Combat Challenge properly

### 3. Ihre Möglichkeiten und Rechte

You have the right to request from Society "Firefighter Combat Challenge Team Austria" access to or correction or erasure of your personal data or restriction of the processing of your personal data as well as the right to data portability. In addition, you can object to the processing of your personal data in some circumstances (in particular, where we do not have to process the data to meet a contractual or other legal requirement). Where we have asked for your consent, you may withdraw consent at any time. If you ask to withdraw your consent to Society "Firefighter Combat Challenge Team Austria" processing your data, this will not affect any processing which has already lawfully taken place at that time. These rights may be limited, for example if fulfilling your request would reveal personal data about another person, or if you ask us to delete information which we are required by law or have compelling legitimate interests to keep. If you have unresolved concerns, you have the right to complain to a competent supervisory authority. Your relevant supervisory authority could be in the place where you live, or where you work, or where a breach of data protection obligations has occurred.

### 4. Data Retention

We will retain your personal data only for as long as we need it for Society "Firefighter Combat Challenge Team Austria" legitimate interest in accordance with applicable law, to fulfil the Event contract or perform a service at your request, or to meet a legal requirement. #### Choices and Rights:

In accordance with the current legal situation, with regard to your personal data you have the right to:
